Your Privacy:

Information Collection and Use

MAESA (Mid-Atlantic Episcopal Schools Association) is the sole owner of the information collected on this site. We will not sell, share, or rent this information to others in ways different from what is disclosed in this statement. We collect information from our users at several different points on our Web site. Our server collects IP addresses, dates and times of visitor, and other general data. IP addresses are not linked personally to identifiable information. We use this information to help diagnose problems with our servers, and to administer our Web sites.

If you supply us with your name, address, phone number, and/or fax number online, you may occasionally receive information from MAESA regarding news and events.

We do not make our mailing list available to any outside organizations or to individuals for solicitations or announcements. We do monitor and filter all communications through the Web site as well as through our servers and require all communications to be within the bounds of our organization's philosophy and goals.

Cookies

A cookie is a piece of data stored on the user's hard drive that might contain information about the user. MAESA does not use cookies of any kind to collect information from the visitors of our site nor do we knowingly link to other sites and servers that do so without expressed purpose or policy.

MAESA's Commitment to Children's Privacy

Protecting children's privacy is especially important to MAESA. It is our policy to comply with the Children's Online Privacy Protection Act of 1998, and all other applicable laws.
